- 6679 **MINUTES**. The minutes and report of the meeting held on 29<sup>th</sup> August 2017 and Special meeting held on 11<sup>th</sup> September 2017 were confirmed and signed as correct records.

- 6681 **MEMBERS' QUESTIONS**. Cllr. Ferguson reported that at a previous Planning meeting she had requested clarification as to who was responsible for taking down planning notices and Cllr. Clokie (ABC) had responded that it was the applicant's responsibility. Currently, the notices were still not being removed. Cllr. 17/01165/AS	25 Shrubcote. Erection of a two-storey side extension. SUPPORT.
17/01254/AS	<u>2 Holly Tree Cottages, Appledore Road</u> . Proposed two storey side and rear extensions (including conversion of existing structures). Proposed additional window to rear elevation. SUPPORT.

## 17/01258/AS Land to the rear of 3-7 High Street.

Reserved matters application for details of landscaping and appearance pursuant to outline permission granted under 16/01529/AS Erection of covered market stalls over existing open paved area. **SUPPORT**.

- 17/01277/AS <u>Garden Cottage, Golden Square</u>. New access to create off road parking space. SUPPORT subject to concerns raised by Kent Highways & Transportation being addressed.
- **17/01279/AS** <u>**3 Highbury Lane**</u>. Prior approval for the change of use from Retail (Class A1) to a Delicatessen (Class A3). **SUPPORT**.

17/01301/AS Golan Croft, Cranbrook Road.

Retention of mobile home. Application for full planning permission. **OBJECT on the following grounds:** 

(i) the proposal is misleading - it appears in fact to be a retrospective application for planning permission as opposed to one for the retention of a mobile home, which the building clearly is not;
(ii) the building is inappropriate in its appearance

and design and is too large for the site;

(iii) the location of the building is inappropriate as it will impact on the outlook of neighbouring dwellings and affect the character of the surrounding countryside which is an area of outstanding beauty.
