TOWN MAYOR'S UPDATE

Wheels grind frustratingly slowly where officialdom is concerned. Understandably most of us would prefer not to increase the size of Tenterden; however we have to comply with Government legislation. With your help and input through all the design stages, the Council has now been able to sign and seal the papers for Tent1.

A new memorial bench donated by the Royal British Legion and the recently completed paving around the War Memorial make a real feature of this part of the High Street. Commemoration of WW1 has been widespread with schools, societies and individuals producing a variety of re-enactments and static displays. Artwork created by our schools will be shown at the Town Hall before Christmas. Unfortunately the Pavilion in the middle of Tenterden Recreation Ground has been allowed to deteriorate. The Council has agreed to spend essential monies to make the building fit for safe use by football teams and anyone wishing to hire the building. The dugouts at the south side of the pitch will be removed as they are no longer required. The Town Hall has undergone a small face lift with redecoration to the foyer and staircase and new curtains in Mayors Parlour and Assembly Room. This improvement adds to the pleasant atmosphere for wedding ceremonies, TODS productions and general lettings.

The main High Street Christmas lights will be switched on after a short church service, candlelight parade and gathering for carols outside the Town Hall on Saturday afternoon 29th November, with our Honorary Freeman, Roger Champion, performing the switch on of the Rotary Club's Christmas tree lights. There will be a Mayoral fundraising event on the evening of late night shopping, 5th December, with Mayors and Councillors from other Cinque Ports towns looking around the market, sampling a hog roast and enjoying a cabaret by the Tuesdays singing group.

The Council has had a good response to its request for nominees for Mayoral and Civic Awards, and a ceremony to present these awards will take place on 11th December. My first five months in office have been most interesting; some enjoyable some requiring a "stiff upper lip". Being a member of the Cinque Port Confederation enhances the activities of Town Mayor both in pageantry and the mix of people one meets. As a Council we have improved our relationship with both ABC and KCC, which is vital for negotiations to take place. The big concern we have at present is the threat to reduce by half the number of Community Wardens throughout Kent. I am sure you will agree that Jo Vos is invaluable in her work with youngsters in the area, and we must fight to retain her services to the community.

FREE PARKING

You can now park in the Bridewell Lane car park free of charge on Sundays and Bank Holidays. It is hoped that this scheme will reduce the number of vehicles parked along the south side of the High Street on Sundays, easing congestion. The controlled hours of this stretch of road will soon be changed to include Sundays, so drivers continuing to park there may be issued with a fixed penalty notice.

TENT 1 DEVELOPMENT

Ashford Borough Council has now given planning permission to the Tent 1 development (the land between Recreation Ground Road and Smallhythe Road), on the provision that a number of issues are corrected and the appropriate Section 106 payments are made. Section 106 payments are vital, as this money is used to provide essential services for the residents of the new development (healthcare, schools etc.). The land promoters must now appoint builders, and it is expected that building work may start as soon as April 2015.



REMEMBRANCE SERVICE

To commemorate the centenary of the outbreak of the First World War the Town Council has renovated the surroundings of the war memorial on the High Street and the Royal British Legion has dedicated a new bench at the memorial, and this was officially unveiled on 4th August 2014.

This year's Remembrance Service will be held at the war memorial on Sunday 9th November 2014.

WORLD WAR 1 EXHIBITION

An exhibition of artwork by local school children, commemorating the centenary of the outbreak of the First World War, will be on show in the Town Hall from the evening of the Christmas Market & late-Night Shopping on 5th December 2014.

What does Tenterden Town Council do?

The Town Council is not burdened by statutory duties to deliver services, which means it can use all of its resources to directly help the community. Recent years have seen new laws brought into place which permit us to do anything that is not specifically prohibited by other legislation. This means that we can be more creative in our thinking than we could in the past, with the goal of making a real difference to the lives of local people.

The Town Council has been involved in numerous activities over the last few years, among them;

- The implementation of the Tenterden Sports and Community Facilities Review, which was designed to identify the needs of the community over the next fifty years and beyond,
- Active involvement in the planning stages of the Tent 1 development,
- Taking over the public toilets in Tenterden and St. Michaels to prevent their closure by Ashford Borough Council,
- The improvement of the play areas at Tenterden and St. Michaels recreation grounds,
- The installation of a new bus shelter on the High Street,
- Giving financial support to a large number of local charities and organisations.
- Extensive cleaning and refurbishment of the war memorial and its surroundings.
- Setting up the Tenterden Parking Forum, to help address some of the many parking issues facing the town.

Code of Conduct for Councillors

You **MUST**;

- Act in accordance with the Council's requirements,
- Make sure that the Council's resources are not used for political purposes,
- Disclose any personal interest you have in matters discussed by the Council.

You **MUST NOT**;

- Attempt to bully or intimidate anybody,
- Do anything to compromise the integrity of anybody working on behalf of the Council,
- Disclose information given in confidence (unless required to by law),
- Prevent anybody from accessing information they are entitled to,
- Do anything that would bring the Council into disrepute,
- Use your position for personal gain.

What do Town Councillors do?

The most important parts of a Councillor's role are to talk and to listen! Meetings of the Town Council are held once every six weeks, usually on a Monday evening, (and contrary to popular opinion, are painlessly brief). It is at these meetings that the recommendations and decisions of the Council's committees are considered and (hopefully) agreed upon.

The Council currently has five committees, and Councillors may join as many or as few as they wish to. Committees also meet once every six weeks (except for the Planning committee, which meets every three weeks), also on a Monday evening. Committee meetings tend to run a little longer than Council meetings, but rarely take much longer than an hour.

The standard Council term is four years (the last election having been held in 2001), although Councillors do sometimes step down from the Council earlier for various reasons, and in this case a 'casual vacancy' will open up, allowing a replacement member to be elected or co-opted.

Who can be a Town Councillor?

It is important that the Council is representative of the whole community. For this reason people of all ages (18 and above) and backgrounds are strongly encouraged to stand for office. You may feel that Council's views do not reflect your own—if so, you are in the perfect position to change this!

Any person over the age of 18 who is a citizen of the United Kingdom, The European Community, or the Commonwealth can be a Councillor if they live or work in Tenterden, or if they live within three miles of Tenterden.
