# 389 **DECLARATIONS OF INTEREST.**

Cllr. Nelson declared an interest in Agenda Item 8, Contract Negotiations, and would leave the room when discussed.

## 390 **MINUTES.**

The minutes and report of the meeting held on 12<sup>th</sup> August 2019 were confirmed and signed as a correct record.

- 392 **REPRESENTATION FROM MEMBERS OF THE PUBLIC.** None.
- 393 **COUNCILLORS' QUESTIONS.** None.

## 394 **SUB-COMMITTEE & WORKING GROUP REPORTS.**

- (a) <u>Cinema Focus Group</u>. The report of a meeting held on 20th August 2019 was **NOTED**. It was **AGREED** to approve the cost of a full building feasibility study for The Pebbles at a cost of approximately £26,845. Calls to tender will be compiled by the Cinema Focus Group and the Town Clerk.
- (b) <u>Kiln Field Reserve & Wildlife Venues</u>. The report of a meeting held on 4th September 2019 was tabled. Cllr. Dr. Lovelidge reported that pond clearance will need to take place at Kiln Field along with the removal of some trees. The budget that had been previously agreed by the Town

Council would cover some of the works required, however, the pond clearance is more expensive than anticipated. Ashford Borough Council (ABC) have been approached for a grant, however, the Sub-committee were requesting that a further £6,250 be allocated by the Town Council in the hope that less would be used if further funding was secured from ABC.

Cllr. Dr. Lovelidge reported that Kent County Council (KCC) have now responded with which grass verges can be left to wildflower. Notices will be produced by the Town Council informing residents that the verges will be left for a year to see what will grow through.

Cllr. Mrs. Ferguson commented on the grass verges along Rolvenden Road, near Castweazle. The verges are in quite a poor state and the removal of thistles should be investigated. Cllr. Mrs. Walder reported that we as a community need to redefine what the verges are for and need to explain why the verges are being left. Cllr. Dr. Lovelidge reported that Plant and Organisational Wildlife is a good website for an explanation of procedures.

It was **AGREED** to increase the budget for Kiln Field by £6,250.00.

# Cllr. Nelson left the Chair and meeting and Cllr. Mrs. Curteis took the Chair.

**The Committee moved into closed session.** Under the Public Bodies (Admissions to meetings) Act 1960, the public and press will be excluded from the closed meeting session due to the confidential nature of this part of the meeting which involves the discussion of confidential staffing matters and confidential financial negotiations.
