(b) Town Hall Focus Group. It was agreed to **DEFER** the decision to accept the quotation from Price Whitehead relating to the architect's brief until the Public Engagement Sub-Committee's report has been discussed at the next meeting on 13th August 2018.

0274 **MILLENNIUM GARDEN**. The circulated wildlife report on the Millennium Garden was **NOTED**. It was agreed to **DEFER** adopting the report's recommendations until the Cinema Focus Group had taken their recommendations to the Council.

0275 **MAYORAL PORTRAIT**. It was **RESOLVED** to accept the Mayoral Portrait and a letter of thanks would be sent to Mr. D. Swaine. It was agreed to **DEFER** where the portrait would be placed as it is unusual for a living Mayor/Councillor's portrait to be hung. It was suggested that the Town Hall Focus Group makes the recommendation for placement, along with a silk cross-stitch portrait of Cllr. Hickmott which was given to him. The cost of framing of the portrait would be brought back to the Committee once obtained by the administrative team. The portrait would be placed in the current Councillors room for safekeeping.

Freeman suggested a spreadsheet be created rather than a consultation document. It was **RESOLVED** to set up a Subcommittee to create a Corporate Plan. Cllrs. Crawford, Nelson and Ms. Walder were appointed. Cllr. Crawford encouraged Councillors to look at Ashford Borough Council's Corporate Plan.
