- 6626 APOLOGIES FOR ABSENCE. None.
- 6627 **DECLARATIONS OF INTEREST**. Cllr. Edwards declared an interest in planning application 17/00873/AS and would leave the room when discussed. Cllrs. Dr. Lovelidge and Nelson declared interests in application 17/00886/AS and Cllr. Nelson indicated that he would leave the room when discussed.
- 6628 **MINUTES**. The minutes and report of the meeting held on 5<sup>th</sup> June 2017 were confirmed and signed as a correct record.
- 6629 MATTERS ARISING.
  - (a) Minute 6620 Application 17/00456/AS Woolpack Hotel. Cllr. Carter reported that so far Ashford Borough Council had refused the colours proposed by the publican, even though those colours appeared elsewhere in the high street. Cllr. Carter asked the two Borough Councillors present, Cllr. Clokie and Cllr. Knowles, if they would note the request for this to be resolved as soon as possible.

- 6631 **PLANNING APPLICATIONS**. The Committee considered the following planning applications. It was **RESOLVED** that its recommendations would be submitted.

## 17/00708/AS Land North of 14 Westwell Court.

Erection of a fifty-six bed care home and 23 units for assisted living (use class C2) comprising 16 cottages and seven flats (including Manager's accommodation) with associated landscaping, parking, stores and service areas, estate roads, access and landscaping buffers.

Cllr. Lusty reported that the developer was considering changing the current plans; Cllr. Lusty had spoken to the Planning Officer who was happy for the application to be deferred to a future meeting.
