- 1. St. Michaels recreation ground (marked (1) on plan) is a general amenity area as well as including a play area.
- 2. There are churchyards at St. Michaels, (2) St. Mildred's, (3) and a small, old cemetery in Station road (4).
- 3. There are two areas of privately owned land at Westwell (5) and Appledore Road (6) crossed by footpaths and used as general amenity land, large parts of which the town council wants designated as country parks.
- 4. The development of houses at Tent1A (southern extension of 250 units) will include a stretch of open general amenity space at (7) which will form a break with the proposed Tent1B development of a similar number of units to the south of Tent1A.
- 5. The development at the rear of Kiln Fields (Cruttenden Close, Abbots Way) included designated open space (general amenity area) at (8)
- 6. The Town Council wishes to prevent development of Hales Place 'orchard'(9) and the Glebe Field (10) in order to retain 'green lungs' close to the town centre and preserve views in both directions.
- 7. There is a small, formal Millennium Garden (owned by the Town Council) just off the High Street at (11)
- 8. Local wildlife sites (coloured yellow on the plan) are kept free of development. This is mainly for wildlife and biodiversity conversation, but some areas (such as Knockwood) are also general amenity areas for walkers, etc. The sites are listed below plans of each can be provided if wanted:
- Sandpit Wood etc. Clapper Hill
- Knockwood
- Ashenden Gill
- Heronden Woods and Pasture
- Friezingham Dykes and Newmill Channel
- Millpond Farm
- Kench Hill
