

# MINUTES AND REPORTS OF THE ANNUAL MEETING OF THE TOWN COUNCIL HELD AT TENTERDEN TOWN HALL ON 15<sup>TH</sup> MAY 2017

- 3064 **THE TOWN MAYOR 2017-2018**. Cllr. Mrs. Smith asked for nominations for the role of Town Mayor for 2017-2018. Cllr. Mrs. Smith had nominated Cllr. Nelson, and this was seconded by Cllr. Mulholland. There being no other nominees, the appointment of Cllr. Nelson was **RESOLVED** by a show of hands. The Sergeant led the Town Mayor, Deputy Town Mayor and Town Clerk from the room, signifying the close of the mayoral year. On returning to the room the Town Mayor took the chair, and duly signed and read aloud his declaration of acceptance of office, and Cllr. Mrs. Smith led Councillors and guests in a toast to the Town Mayor.
- 3065 **APOLOGIES FOR ABSENCE**. None.
- 3066 **DECLARATIONS OF INTEREST**. Cllrs. Mrs. Curteis, Mulholland and Mrs. Smith declared an interest in Agenda Item 28; St. Michaels Village Hall (see Minute 3091).
- 3067 **DEPUTY TOWN MAYOR**. The Town Mayor called for nominations for the role of Deputy Town Mayor for 2017-2018. Cllr. Hickmott nominated Cllr. Mrs. Curteis who was seconded by Cllr. Lusty; Cllr. Nelson nominated Cllr. Mrs. Ferguson who was seconded by Cllr. Sugden; and Cllr. Dr. Lovelidge nominated Cllr. Mulholland who was seconded by Cllr. Knowles. With no other nominations having been received, a written ballot was requested and **AGREED**. Cllr. Mrs. Curteis received 2 votes, Cllr. Mrs. Ferguson received 7 votes, Cllr. Miss. Gooch received 3 votes and Cllr. Mulholland received 4 votes. As Cllr. Mrs. Curteis received the fewest votes, she stood down and a second written ballot was conducted. On the second round of voting, Cllr. Mrs. Ferguson received 5 votes. As Cllr. Miss. Gooch received the fewest votes, she stood down and a third written ballot was conducted. On the third round of voting, Cllr. Mrs. Ferguson received 9 votes and Cllr. Mulholland received 5 votes.

The Town Mayor declared Cllr. Mrs. Ferguson to be the successful candidate. The Sergeant-at-Mace led Cllr. Mrs. Ferguson from the room. Upon their return Cllr. Mrs. Ferguson duly signed and read aloud her declaration of acceptance of office and took the seat of the Deputy Town Mayor.

- 3071 **FORMER STANDING COMMITTEES**. #### 3072 INTERNAL AND EXTERNAL COMMITTEES.

(a) <u>Selection to Committees</u>. The selection of councillors to the new Internal and External committees took place by two administrative staff picking a councillors name 'from a hat' then picking a coloured token from 'a separate hat'. There were 16 tokens in total, 8 of one colour and 8 of another. The following selections were made:

(b) <u>Swapping of Committees</u>. The Town Mayor asked if any councillors wished to swap committees and Cllr. Dr. Lovelidge requested swapping to the Internal Committee. Cllr. Knowles agreed to swap with Cllr. Dr. Lovelidge. No other swaps were requested.

- (c) <u>Substitutes from the Internal Committee to the External Committee</u>. The Town Mayor asked councillors on the Internal Committee to indicate if they wished to be a substitute on the External Committee. Cllrs. Isworth, Hickmott and Dr. Lovelidge raised their hands and, as there were no other expressions of interest, the three councillors were appointed.
- (d) <u>Substitutes from the External Committee to the Internal Committee</u>. The Town Mayor asked councillors on the External Committee to indicate if they wished to be a substitute on the Internal Committee. Five councillors expressed an interest for the three slots, therefore, those councillors picked a coloured token from the bag which contained three for the Internal Committee and two for the External Committee. Cllrs. Carter, Mrs. Ferguson and Knowles were appointed.
- (e) <u>Appointment of Chairman to Internal Committee</u>. The Town Mayor asked those councillors on the Internal Committee for nominations for the position of Chairman. Cllr. Sugden proposed Cllr. Dr. Lovelidge and Cllr. Hickmott proposed Cllr. Lusty. Cllr. Lusty did not wish to stand, therefore, Cllr. Dr. Lovelidge was appointed as Chairman of the Internal Committee.
- (f) <u>Appointment of Chairman to External Committee</u>. The Town Mayor asked those councillors on the External Committee for nominations for the position of Chairman. Cllr. Mrs Smith proposed Cllr. Mulholland and Cllr. Knight proposed Cllr. Carter. A written ballot was conducted and Cllr. Carter received 9 votes and Cllr. Mulholland received 7 votes. Therefore, Cllr. Carter was appointed as Chairman of the External Committee.
- 3073 **PLANNING COMMITTEE**. The following members were appointed to the Committee: Cllrs. Carter, Mrs. Curteis, Edwards, Miss. Gooch, Isworth, Dr. Lovelidge, Lusty, Mulholland and Nelson. Cllr. Lusty was appointed as Chairman.

- 3085 **COMPLAINTS PROCEDURE**. The Town Council's complaints procedure was reviewed and **RESOLVED** to be correct.
- 3086 **FREEDOM OF INFORMATION**. The Town Council's procedure for handling requests under the Freedom of Information Act 2000 and the Data Protection Act 1998 was reviewed and **RESOLVED** to be correct.
- 3087 **DEALINGS WITH THE PRESS/MEDIA**. The Town Council's procedure for dealing with the press/media was reviewed and **RESOLVED** to be correct.
- 3088 **TIME AND PLACE OF TOWN COUNCIL MEETINGS**. The schedule for ordinary meetings of the Town Council and its committees up to and including the 2018 Annual Town Council meeting had been circulated with the agenda, and was **RESOLVED**.
- 3089 **SERGEANT-AT-MACE**. Mr. M. Winter expressed that he was willing to continue in the role of Sergeant-at-Mace, and his appointment for 2017-18 was **RESOLVED**. The Town Mayor recorded his thanks to Mr. Winter for his continued support as Sergeant-at-Mace.
- 3090 **TOWN CRIER**. Cllr. Hickmott expressed that he was willing to continue in the role of Town Crier, and his appointment was **RESOLVED**. Cllr. Hickmott informed the Council that he was available for local events and members of the public/businesses were welcome to contact him direct.
- 3091 **ST. MICHAELS VILLAGE HALL**. Cllrs. Mrs. Curteis, Mulholland and Mrs. Smith had declared an interest in this item as Trustees of the Village Hall. The Town Mayor reported that the Standing Orders, Financial Regulations & Donations Sub-Committee had met on 4<sup>th</sup> May 2017 and recommended a £40,000 loan to the St. Michaels Village Hall Committee. It would be interest free for the first year then at 0.25% interest for the remainder of the term. The loan would go towards the replacement of the village hall roof. The Council **RESOLVED** the unsecured loan of £40,000 to the St. Michaels Village Hall Committee.
- 3092 **APPOINTMENT OF ARCHITECT**. The Town Clerk reported that the position of Landscape Architect and Facilitator for the recreation ground reordering focus group had been put out to tender and there had been several expressions of interest. The Town Clerk proposed that he plus two Councillors conduct the selection process and it was **RESOLVED** that Cllrs. Sugden and Mulholland should be involved in addition to the Town Clerk. Cllr. Knight proposed that Cllr. Carter be included in the selection process given his relevant experience and the Council **RESOLVED** that he be included.

- (a) The Town Mayor congratulated the Town Clerk on achieving his Certificate in Local Government Administration Qualification which now means the Town Council can adopt the General Power of Competence under the Localism Act and a resolution would need to be passed at the next Town Council meeting. This also meant that the Town Council could apply for the Local Council Award.
- (b) The Town Mayor provided an update with regard to the regeneration project focus groups. The councillors assigned to each focus group had been provided with the list of people who had registered and each would be contacted soon. The Town Mayor stressed the importance of arranging the first focus group meetings as soon as possible.
- (c) The new Good Councillors Guide was available and could be downloaded from the Kent Association of Local Council's website. It was agreed that the Town Clerk's office would order 10 hard copies for councillors.
- (d) The twice yearly Tenterden litter pick would be taking place on Sunday, 4<sup>th</sup> June 2017 from 11.00 am to 1.00 pm and leaflets would be available shortly.
