- b) An alternative "container" system on the recreation ground was quoted at nearly £50,000 and would be subject to a change in position depending on the design of the re-ordering.
- c) A further alternative container solution has been trialled at the cricket club and these standard containers are too small to allow entry by our equipment.

Contractors will start the access to St Michaels recreation ground as soon as KCC issues a "crossing licence" and this is likely to occur early in the new year. This would allow safe hard access to the toilet area and beyond.

A potential position for the maintenance facility would be beyond the toilet and parallel with the Jireh chapel graveyard. (Please see attached diagram). This position would have the following advantages:

- 1. Close to water supply, sewage and electrical services
- 2. Screened from the Jireh by existing trees & less likely to provoke planning opposition.
- 3. Hard access on and off the recreation ground
- Low cost. (steel structure buildings can be purchased for around £30,000).

There would clearly be an additional cost to lay a concrete plinth and connect to the nearby services.

The facility would also obviously be further from the centre of Tenterden than is ideal.

I feel it is worthwhile to instruct surveyors to investigate the feasibility of siting a building there in case alternatives do not materialise. We would then be in a better position to move quickly.

CYCLING FACILITIES IN TENTERDEN

Background

Councillors are reminded of the council's decision that the council actively seeks ways to improve cycling facilities in the civil parish of Tenterden.

The Tenterden Cycling Strategy steering group has been investigating ways of improving cycling facilities in Tenterden, including extending the existing old railway cycle way that currently runs from Grange Road to Drury Way, so that it runs all the way to Tenterden Town Station, and cyclists can then easily access the High Street via Station Road. Such an extension is likely to be of great benefit to local residents – not just cyclists, but also providing a safe walking and scooter route into town – and in consequence to local businesses, and will reduce vehicular traffic into town, car parking problems, etc.

A possible route, involving only three sets of landowners, has been plotted and KCC is happy to support the extension in principle. There are, however, numerous details to consider and potential problems to resolve: the exact route to be taken, seeking the agreement of landowners and satisfying their concerns, agreeing on the surface of the cycle way, creating it, setting up signage, etc. These details are beyond the resources of a small group of volunteers, which is what the steering group amounts to.

Sustrans, the cycling promotion charity, is able and willing to investigate all these aspects and liaise with the various parties involved, for a fixed fee of £5,000.

Actually creating the cycle way will involve further resources, but if it is established as viable subject to resources for its construction, that will make it more likely that KCC will allocate resources, and grant funding can be sought on the basis of a firm and achievable proposal.

Proposal

I propose that the Town Council allocates £5,000 to be paid to Sustrans to undertake the work involved in further investigating, negotiating and (it is hoped) agreeing the extension of the cycle way as envisaged, with such variations and adjustments as may be recommended.



- Contractor C local business; substantially more expensive.



Present: KCC councillor Mike Hill, two KCC highways engineers (Tara O'Shea and Jennie Watson, Ros Debling (Community Speed Watch, Woodchurch Road), Kent and Medway safety camera partnership representative, town councillor Justin Nelson, and the Town Clerk

Information:

KCC will only do work that progresses its "casualty reduction programme" – KCC has no resources for anything else.

KCC's intervention criteria require 6 or more "injury crashes" within a 3 year period and a 50 metre radius in urban areas (4 or more such crashes in rural areas) with common causes capable of being "engineered out" before they will take action

While the police have suggested that KCC should undertake any required research, KCC take the view that if speed limits are being exceeded then it is for the police to enforce those limits - informed by Community Speed Watch data, perhaps; instead of commissioning a survey, TTC could buy a data-collecting SID to collect speeding data

Third party funding is possible: if a proposal is useful, legal and fully funded, KCC will authorise it. Funding includes £3k for a traffic order, but any proposal must be backed up by data, consultation and drawings

KCC will supply a list of "approved" traffic consultants - but it is clear they are sceptical of consultants' reports, assuming them to be written to suit the client's prejudices, rather than being objective

There are two KCC reports awaited - on traffic speeds on the Rolvenden Road and Ashford Road approaches to Tenterden. KCC officers will chase these up

The last KCC speed review was carried out in 2009 and all recommendations have been implemented (on A roads only, due to budget cuts); KCC will supply details of the review/recommendations for Tenterden

The possible extension of the 30mph speed limit at St Michaels was investigated in 2009, but it was decided that the proposed extension was, in effect, into open countryside, so not appropriate. On the other hand, re-siting the variable speed sign so it applied to the 30mph limit was not appropriate as that would place it in a too-crowded area. The issue is therefore not capable of resolution, whatever resources are made available.

The traffic speed surveys are now in place at both St Michaels and Rolvenden Rd.

Possible actions:

- Introduce countdown signs to speed limited areas (for some reason, KCC do not use these, though they seem effective in East Sussex)
- · Change the variable speed sign at St Michaels to read "Slow down"
- · Erect "village gates" and add road markings at Woodchurch Road (Clay Hill)
