
Highways and Amenities Committee – Monday 13th March 2017 <u>Ceremonial Beacon</u> Agenda Item 8

The Lions Club of Tenterden wishes to donate a permanent ceremonial beacon (for use at jubilees etc.) to celebrate the centenary of the Lions movement and the 50th anniversary of the founding of the Tenterden branch.

Advice was sought from the Queen's Pageantmaster, who supplied the standard plans for a traditional beacon. These have been given to a blacksmith who has supplied a quote of £1,200.00 for the work. The Lions Club will meet this manufacturing cost, plus £100.00 for a plaque identifying it as being donated by them. The Town Council would need to pay for the installation of the beacon, which could involve outside contractors to sufficiently root the beacon into the ground.

It is suggested that a position of prominence near the High Street corner of Tenterden Recreation Ground be chosen as the location. This will allow ceremonial lighting events to be visible from the High Street, and will minimise possible vandalism (due to the relatively exposed position). Locating it on the Recreation Ground would allow for significant attendees at an event, if necessary.

Below is a diagram showing the suggested location:




Proposal: That the Lions Club is given consent to donate a ceremonial beacon, to be located on the north western corner of Tenterden Recreation Ground. A maximum budget of £1,000.00 to be allocated to installation if necessary.

Currently Tenterden FC hire the football pitch at £12 per session and any individual bookings by other clubs are charged at £30 per session.

There has not been an individual charged booking (there have been 2 free charity matches recently) at the recreation ground for some while and our income from the football club is around £240 per annum.

The football club also hire the pavilion at the normal hourly rate of £6.25.

We are aware that other teams and fitness clubs use the pitch without permission but this is impossible to police. When this occurs the pavilion is not used.

At present the situation seems unfair to the football club. They are obviously the main user of the pitch but are currently the only ones who pay.

Proposal: That the charge to the football club for the pitch should be withdrawn, but the pavilion charge should remain in place.

Highways and Amenities Committee - Monday 13th March 2017 Ashford Rd Paving - Update Agenda Item 10

There has been a long-standing problem with the paving on Ashford Rd on the stretch between number 5 and the Mail Sorting Office. The problem is cause by vehicles crossing the pavement to reach commercial properties on that stretch of road. The pavement is the responsibility of KCC, but the hard areas to the front of the retail properties belongs to those properties.

This issue has been reported 6 times to KCC within the last year and the repairs have been either a temporary patch or replacement concrete slabs which are broken again within days of fitting.

On each occasion recently I have asked for a more permanent solution to the issue as there seems little point in expenditure on very short term solutions.

My latest contact with KCC (via Cllr. Hill's secretary) has brought the following response. KCC are proposing to investigate the possibility of a crossing licence and dropped kerb at the expense of the business owners there. If this option is not viable they will approach ABC for permission to apply tarmac to the pavement area instead of concrete slabs (this is part of the conservation area). Tarmac will also require a stronger sub-base to avoid the surface dipping with the weight of vehicles.

Proposal: Information only. Town Clerk to chase up within a month.

Message: Dear all, I would like to introduce myself as the manager of the new extra care scheme in St Michaels called Spires, and discuss whether you would consider supporting a repair or improvement to the existing pedestrian island crossing opposite the new Extra Care scheme here. I've had complaints of some of the residents using the private roads/laybys next to the scheme to walk towards Tenterden and after talking to them, the main reason is because of the dangerous crossing on the pavement across from the scheme itself; it puts the residents at a very high risk of falls and slips. When spoken with, they all recognise that using private land is not okay, however due to how vulnerable most are on their feet, feel they have little choice in light of the quality of the crossing provided. I've contacted Kent County Council who asked I make an initial contact with yourselves, as they cannot agree changes without local community support. Whilst there is a crossing further up t he road near the fuel garage in St Michaeals, the amount of walking required to get up to the station and then back down again just to visit the Shop Around The Clock etc is too much for them to be able to manage. At the meeting on 30th January 2017, the following was agreed:

3130 MAINTENANCE EQUIPMENT. The Site Manager reported the importance of obtaining a second buggy, as the existing vehicle could only transport two of the four members of the Maintenance Team at a time. Cllr. Thorpe advised that lease-hiring a buggy could be a cheaper option. A budget of £16,687.93 for a new buggy was AGREED, subject to Cllr. Thorpe finding quotations for leasing; whichever option presented the best value would be pursued.

A quotation has been received from Burden Bros Agri Ltd and it shows that over a five-year period, the total amount payable would be £22,390.20 plus VAT. This quotation includes a monthly maintenance plan and annual servicing and is based on 250 hour's usage per annum. At the end of the lease, additional hours above this quoted usage would be charged at a rate of £4.00 per hour in addition to any unnecessary wear and tear on the buggy.

The Council's current buggy, which is now 6 years old, is serviced once a year at a cost of approximately £200. Therefore (including five years servicing on top of the purchase price above), the cost of lease hiring would be £4,702.27 more expensive than purchasing the buggy.

In light of the above, the Town Clerk is pursuing the option of purchasing a new buggy at a cost of £16,687.93.

The attached quotation was requested late last year then postponed for the public consultation. Two other quotations were requested at the time and representatives of those companies attended site but despite reminders only one quotation has been forthcoming. The price of the attached quotation compares favourably with previous similar payments.

Repairs are required to the edges of the "wetpour" rubberised matting surrounding the play equipment on the Recreation Ground as it is pulling away from the edges and will present a trip hazard if the deterioration continues. The very popular old Wicksteed rocking horse also needs repair.

In addition to this, contractors were asked to quote to replace the sprung skateboard ride which is rarely used.

As the wetpour fixes are a safety issue they should go ahead. Councillors may wish to consider whether the installation of the bird's nest swing should be postponed until the re-ordering of the recreation ground. This equipment can, however, be moved if necessary and this swing is popular with older children who are less well served on the recreation ground.

Funds are available from an earmarked Play Equipment reserve. Total quotation (exclusive of VAT) £10195

Proposal: That the safety repairs should be undertaken as quoted and the bird's nest swing installed in place of the skate-board ride.

RESPONSIBILITY FOR ORGANISING THE TWICE-YEARLY "TENTERDEN CLEAN-UP"

Background

Over the past few years, a twice-yearly litter-pick around Tenterden has been organised by the (very) small membership of Transition Town Tenterden (T3), with the support (and co-branding) of the town council). It has now been suggested (by T3) that the town council should take over the organisation, and brand the event as a specifically town council initiative. This should encourage wider take-up and involvement by residents and will certainly raise the profile of the town council locally.
