For 3 of the last 4 years an ice cream concession has been awarded to contractors to trade during the summer months on the recreation ground.

Whilst the letting to the Gelato ice cream cart has gone well, there are criticisms that the cart is not always present. In addition to this, the contract should be reviewed occasionally to ensure that the Town Council is maximising its income from the concession. Currently £1000 p.a. is charged.

For the 2019 season, I suggest we advertise for expressions of interest and then ask for sealed bids for the concession using an anonymised contract for bidders' information.

This process needs to be started early as the ABC licence to trade will be required by the successful applicant and in some cases planning permission is needed.

Proposal: That the recreation ground ice cream concession should be put out to competitive tender each year.

- That all early public participation in the meeting should be re-worded on the agenda as representation from member of the public (rather than questions from..).
- That an agenda item should be added to each committee and Town Council agenda to invite questions from the public on matters discussed.

Routine maintenance checks have flagged-up signs of deterioration in the 'Wet Pour' surface at St Michael's. Some of the joins in the surface are splitting apart and are lifting in places. Some examples shown:



Although this is not considered to be dangerous it will continue to deteriorate over time. 'Vitaplay' have been to look at the surface and have provided a quote for repair. This is guaranteed for 12 months. A complete resurfacing would be guaranteed for 5 years but would be a considerable expense.

The total quoted for cost of the repair is £1,388.00 plus vat.

Proposal: That TTC should agree to carry out the repairs before the play area surface deteriorates further or becomes dangerous.

Internal Committee 10th September 2018 Honour Boards Rewording / Replacement Agenda Item 12

The Honour Boards in the Assembly Room are running out of space. A suggestion has been made to remove the names listed on the far right-hand column on the large board to allow this space to be re-worded with the Town Mayor's from 1974.

The existing smaller board to be re-worded with lists of the Law Officers and Honorary Freeman. The Town Clerks to be listed on a separate new board.

Advice has been sought from 2 companies:

T. Pollard uses a traditional handwritten gold leaf method. The total quoted for cost of the rewording existing honour boards and one new board is £2,825 plus vat. (He cannot guarantee that the brown background would be a perfect match but would get it as close as possible.)

Maidstone Signs who use a modern method involving printing.

Maidstone Signs feel that re-wording the existing boards, using modern printing methods, would not give a professional finish and are not be willing to carry out this work. They have supplied a quote for providing a new board, using modern printing methods. Samples to be tabled.

Third company information awaited.

Note: the removal of names from a board is likely to result in a mismatch of background colours. It should also be noted that signwriting is a dying art and if we opt for a solution which is dependent on this practice we risk having to change methods later.

Proposal: That TTC should consider whether they want to re-word the existing boards and start a sign written new board; or leave the existing boards as they are and start two new boards using modern printing methods that can easily be added to in the future.

Internal Committee 10th September 2018 Recreation Ground Access Agenda Item 13

We are experiencing issues with unauthorised vehicle access on the "top half" of the recreation ground. A number of fitness classes use the recreation ground for their sessions and vehicles are regularly pulled onto the recreation ground for the duration of the lessons. There is also a constant concern that this area is currently unprotected, whereas the Football Pitch and St. Michaels Park are.

From the car park down to the Leisure Centre access is restricted by posts, some of which are removable. This system is a cheap and effective method of controlling access to the recreation ground.

Our maintenance staff could easily extend this provision to the top half of the recreation ground, leaving lockable posts which collapse to accommodate large fairground vehicles near the junction with Oaks Rd, and a further lockable removable post near the toilet to allow access to our own vehicles.

This would have the additional benefit of controlling access for vehicles at events, when we could board the open access areas to stop damage to the surface.

Cost: Materials only, £250 for wooden posts and approximately £140 for collapsible posts.

Proposal: That access to the recreation ground should be restricted by the installation of posts.
