Re: Proposed amendments to parking controls in Tenterden

Ashford Borough Council, as agents working on behalf of Kent County Council is proposing to make a Traffic Regulation Order, which will bring into force amendments to parking controls in Tenterden (the area known as Tent 1A)

## Proposal

Creation of a Restricted Parking Zone within the boundaries of the new development, in line with the expectations set out in the Planning Conditions. The reason given (condition 19) would be-

"To ensure that streets remain free of clutter in the interests of visual amenity."

A Restricted Parking Zone (an "RPZ") is an area in which all the streets are subject to waiting restrictions, other than lengths of road where parking places are designated, whether these parking places bear road markings or not. The proposal will allow management of on-street waiting, parking and use of non-allocated visitor bays

## These changes are being proposed in order-

- To avoid danger to persons or other traffic using these roads and for preventing the likelihood of such danger arising.
- · To facilitate the passage of large vehicles on these roads.





 To preserve or improve the visual amenity of the area through which the road runs

A notice giving details of the changes proposed by this Traffic Regulation Order is enclosed herewith along with a plan showing the proposed changes.

# Background

# What is a Restricted Parking Zone?

A Restricted Parking Zone (or 'RPZ') is an area where the entrance for vehicular traffic has been indicated by a sign and in which no yellow line road markings have been placed.

In other words, this allows for a more restrained form of restriction, more in keeping with the Vision Statement and Planning Conditions

Although there would be no yellow lines on the road surface, a 'no waiting' restriction would apply. This means that one would be permitted to undertake genuine loading or unloading (e.g. moving into or out of the property) or to pick up or drop off a passenger, for example.

The basic sketch below shows the key factors-

- No single or double yellow lines marked on the ground.
- Entrance signs to alert motorist that they are entering a zone (exit signs on the rear for those leaving the zone).
- Each bay, or set of bays, signed to indicate parking places
- Parking bays may or may not be lined. Markings can be omitted if the bays vary, in pattern or colour, from the surrounding parts of the road and any adjoining bays.



#### Please note:

This sort of scheme is possible within the Tent 1 development because, unlike on most **existing** streets, there are both adequate off-street parking for the residential properties and specific non-allocated parking bays, mainly set aside from the main highway.





# What are we trying to avoid?

# Footway parking

Without a separate order agreed by the highway authority (Kent County Council), footway parking is not a civil parking contravention.

Given that the intent for the development is to direct parking to off-street bays belonging to private properties or in non-allocated visitor bays, some form of restriction would be required to prevent this sort of parking. Only the police can deal with the offences of dangerous parking or obstruction.

Within a Restricted Parking Zone, a Penalty Charge Notice could be issued to vehicles parked outside of marked bays.

See examples below of typical footway parking. The vehicles shown would not normally be parked in contravention of civil rules, unless, as in an RPZ, there is an underlying restriction that applies to highway, pavement and/or verge.



#### Obstruction

The police enforce unnecessary obstruction, as well as dangerous parking.

Within a Restricted Parking Zone, a Penalty Charge Notice can be issued to vehicles parked outside of marked bays, unless there is an evident exemption, such as genuine loading activity.

See below an example where banksmen are obliged to direct traffic due to the presence of parked vehicles.

The creation of a Restricted Parking Zone (an "RPZ"), which is an area in which all the streets are subject to waiting restrictions, other than lengths of road where parking places are designated, whether these parking places bear road markings or not.

The proposal will allow management of on-street waiting, parking and use of nonallocated visitor bays within the following areas-

Bishop Crescent	Introduction of restricted parking zone on adoptable highway. Designated parking only in signed bays
Burgess Drive	Introduction of restricted parking zone on adoptable highway. Designated parking only in signed bays
Fuggle Drive	Introduction of restricted parking zone on adoptable highway. Designated parking only in signed bays
Goodsall Road	Introduction of restricted parking zone on adoptable highway. Designated parking only in signed bays
Holdstock Road	Introduction of restricted parking zone on adoptable highway. Designated parking only in signed bays
Mercer Drive	Introduction of restricted parking zone on adoptable highway. Designated parking only in signed bays
Pierce Lane	Introduction of restricted parking zone on adoptable highway. Designated parking only in signed bays
Recreation Ground Road (within bounds of Tent 1A development)	Introduction of restricted parking zone on adoptable highway. Designated parking only in signed bays
Three Fields Road	Introduction of restricted parking zone on adoptable highway. Designated parking only in signed bays




