Minute 0109 - Tenterden Leisure Centre Trust. It was agreed to award a grant of £75,000 to Tenterden Leisure Centre Trust. The Town Clerk confirmed that the donation would come from land receipts, not the Community Chest fund. It was also agreed that the Leisure Centre should be advised to produce a press release with regard to their proposals for the expansion.

Minute 0111 - Next Generation Youth Cafe. It was agreed to award a £2,000 revenue grant to the Zion Baptist Church towards the continuing employment of Youth Workers, with ABC and KCC being approached to each fund a third in order to meet the full request of £6,000. Progress will be reviewed by the Town Council to ensure the Youth Café receives the full £6,000 grant either from the Town Council or a combination of authorities. Cllr. Dr. Lovelidge suggested that other parishes be approached for future funding as the Youth Cafe does cover many surrounding villages.
