1 Respective responsibilities of the body and the auditor

Section 1, Assertion 5 has been incorrectly completed. Information received from the smaller authority suggests that a full risk assessment was not carried out in the year and reported back to full council. On this basis, the response to Section 1, Assertion 5 should have been 'No'.
