SELECTIVE NEIGHBOURHOOD PLAN WORKING GROUP MEETING HELD ON 1st May 2019

Notes of a meeting of the Selective Neighbourhood Plan Working Group.

Present:

Cllrs. John, Crawford, Jean Curteis and Kate Walder and, non-council members: Richard Archer, Jim Boot, Richard Masefield, Nic Phillips, Sue Quinton and Graham Smith.

Apologies:

Joshua Franklin and Siggi Nepp.

1. Launch Preparations

- a) The Launch presentations are in progress. There will be a full rehearsal before the first launch event at St. Mildred's on Tuesday 7th May at 10.00. Nic Phillips advised that the Camera Club were having a meeting that evening and he would ask them if they would allow us to have some lights for the Launches. If they were not able to loan them then maybe we could make a donation to the Camera Club.
- b) The facilities at St. Mildred's Church were discussed. There were various discussions on the facilities available. Nic Phillips suggested that it might be a good idea to put some greenery in the church. Kate Walder offered to bring 20 small trees.
- c) Promotion leaflets, banner etc. 5000 leaflets had been distributed and a banner was put up on the Recreation Ground on 30th April 2019. The launch meetings had been promoted on Facebook and Instagram. The Press Release and Launch leaflet had been put on the Tenterden Town Council website. Richard Masefield suggested that people should were possible take photographs so that these could go into a scrapbook. Nic Phillips suggested that maybe we should involve the Camera Club to help to do a project and to do a portfolio.
- Name badges would be produced for Members of the Steering Group and Working Groups.
- e) Catering. The catering was being organised by Jean Curteis. There would be a cold finger buffet and fruit juices and water available.
- f) VIP attendees Damian Green would be attending the Launch on the Saturday and Simon Cole and Ian Grundy would be attending the Launch meeting on the Wednesday. The Sussex Express will be sending a photographer.
- g) Nic Phillips suggested that there would need to be somebody at the door to complete registration forms when they leave. Kate Walder said she would ask her daughter to do. Sue Quinton suggested that it would be a good idea to have a box to put all the forms in.

2. Recruitment for Steering Committee & Working Groups

There are three more spaces for three more members. Jim Boot advised that once we have appointed an Officer we could then appoint a Secretary. John Crawford suggested that an Officer should be appointed at the next NHP meeting.

3. Action Plan for Working Groups

Jim Boot advised on the action plan for working groups.

Cycling, Walking and Riding Group will do an audit of rights of way.

Biodiversity and Wildlife will undertake a review of existing wildlife and a map of the sites.

Landscape Character – a report has been produced for the Local Plan and guidance on the environment is in place. It is a technical piece of work. Ashford locality will provide a technical support package. They do a lot on landscape character so it would be worth applying to them. They have a desktop study and analysis and a good background paper. Jim Boot has a report for the greenspaces group and there would be assessments of greenspaces and those disregarded e.g. proximity to the town etc. and guidance will be produced.

Communications and Engagement - Jim Boot has some useful guidance on what to do.

4. Budget Preparation

John Crawford advised that a Treasurer should ideally be appointed at the next meeting.

5. "Locality" Grant

The "Locality" Grant is not open yet. Once our budget needs are known, then application will be submitted.

6. Outstanding Questions with Ashford Planning Unit

The questions asked to Ian Grundy and Simon Cole regarding the LGS Designation Guidance for Protected and Semi Protected Areas were summarised in a document, which was circulated to the Committee by John Crawford. It was agreed that Non Statutory Designated Areas provided insufficient protection to important green spaces, including Turner's Field and the Recreation Grounds. Jim Boot agreed we should produce a long list of green spaces and then whittle them down to the core green spaces based on evidence collected.

7. Any other Business

Jim Boot advised that The Community Land Trust has a policy within the Ashford Borough Council Local Plan. John Crawford advised that we have representatives on the CLT but is not run by the Tenterden Town Council.

All committee members would be required to sign a Code of Conduct and declaration of interest.

It was agreed that future meetings would take place on the last Thursday of every month at 4 p.m.

Neighbourhood Plan - TTC Planning Report June 2019

Since the approval of the Neighbourhood Plan (NP) Steering Committee on the 10 December 2108, the following shows the important milestones that have been achieved:

- On the 10th December 2018 TTC Planning Committee, it was resolved to "produce a Selective NP, in conformity with the Ashford Local Plan that defines a coherent and forward-looking plan for Tenterden. It should establish a network of valuable green spaces [designated local green spaces] with interconnecting green passageways [where possible] to promote the health and wellbeing of its residents, indigenous wildlife and continue to attract visitors to the town."
- Initial funding of £5,000 was approved. £10,000 had been put forward in the Precept proposal for 2019/20 towards the NP.
- 3. Cllr Curteis, Cllr Walder and Cllr Crawford were appointed to the steering committee.
- TTC application for the "Designation of a Neighbourhood Area" was formally accepted on 21st December 2018
- James Boot Freelance Community Planner was appointed February 2019 as consultant to the NP steering committee
- Ashford Borough Council formally issued designation notice on the 12th March stating: The
 application is approved and the area of Tenterden Parish as shown on the plan attached is
 "Designated as a Neighbourhood Area"
- Pre launch of the 3rd April held in the town hall and was a considerable success. Approximately 60 residents attended with a considerable number of them volunteering to help.
- 8. Terms of Reference for the NP steering committee was approved on the 8th April.
- Formal launch of the NP to the local community took place on the 7th, 8th and 11th May. Just under 600 residents attended. The key feedback metrics were:
 - a) Favourite green space to protect:
 - i. Limes Land
 - ii. Westwell Land / Rogersmead Wood
 - iii. Knockwood
 - iv. Turners Field
 - b) Favourite view to protect:
 - Eastwell Meadows / Railway Station (across to AONB)

Chairing:

The Sub-Committee shall elect its own chairman for individual meetings on the basis of a vote by the majority of Sub-Committee

members in attendance

Frequency of meetings: and quorum: The Sub-Committee shall meet

(a) as often as it deems appropriate to keep abreast of developments relating to its functions and delegated authority

or

(b) on the advice of the Standing Committee

Quorum:

Half of the Councillor members with a minimum of three

Record of meetings:

If no officer is present, a member of the Sub-Committee shall be appointed at each meeting of the Sub-Committee itself (by majority vote of the members of the Sub-Committee in attendance) to take the minutes of that meeting. Such minutes shall be made publicly available, unless

(a) the information therein is of a commercially sensitive nature

or

(b) doing so would constitute a breach of data protection law

Where the Sub-Committee is involved in meetings with third parties and no formal minutes are taken, a member of the Sub-Committee shall report to the Standing Committee on the discussion and the outcome of the meeting. The committee shall decide whether the whole or any part of any such report shall be treated as confidential

Reporting mechanism:

The Sub-Committee shall report to the Committee as often and in such manner as the Sub-Committee deems appropriate in order to keep the Committee informed of progress, and also on request by the Committee. Such reports shall be publicly available unless the Committee or the Council decides otherwise under Standing Order 3d.

Aim:

The aim of the subcommittee is to reconsider the protection afforded to the conservation area within the parish of Tenterden, its high street and listed buildings.

Functions & delegated authority:

The role of the Sub-Committee is to -

- Contact Ashford Borough Council to understand their approach through the CAMP (Conservation Area Management Plan) initiative and how Tenterden Council can work collaboratively with them.
- Follow Historic England methodology for conservation appraisal
- Review the nuances of the 2030 Ashford Local Plan Polices for the borough and in particular to Tenterden
- Review success of protecting Tenterden Conservation Area from unwanted developments.
- Agree Tenterden action plan with Ashford Borough Council for input into the CAMP initiative.
- Consult the public on the draft recommendations for Tenterden
- · Full Tenterden Council to consider for adoption
- · Submit recommendations to Ashford Borough Council.

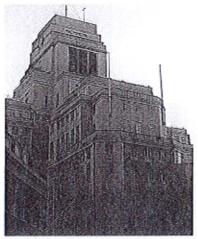
Paddington Station Conservation Strategy and Masterplan

Dear Justin,

We have reviewed your outline brief with Alan Baxters and we think it looks like a really interesting project and we would be very interested in collaborating on it. It is quite possible that no Conservation Area Appraisal was ever carried out for Tenterden and if this is confirmed to be the case, we agree that a Conservation Area Appraisal would be the starting point. Most good appraisals incorporate management guidance or a plan so it could be part of the appraisal or a separate document.

I have attached our CVs and a sheet from Alan Baxter Associates giving some background to their conservation team. As I mentioned in my email last week, we collaborated with them on the London Borough of Tower Hamlets Conservation Area Character Appraisal and Management Guidelines for two conservation areas prior to developing proposals and design guidance for regeneration of the private and public domain, including improvements to railings and hard landscaping.

ABA are currently finishing a set of Conservation Area Appraisals for Sevenoaks District Council, each of which include a section on management and they recently carried out an extensive project for Craven District Council and Historic England to provide robust evidence for Craven's emerging Local Plan. The project involved writing 16 conservation area appraisals, assessing three other villages as possible conservation areas, and analysing the potential impact of development on the historic environment for 28 proposed allocation sites. The project involved developing a methodology for analysing the contribution of open space to the significance of conservation areas that Historic England has since incorporated in their Conservation Area Appraisal Designation and Management guidance. One of the team was brought up in Kent and her family are still based there, so she knows Tenterden well.

I would suggest that our combined fee would be in the region of £20k + expenses and VAT but we would need to fine tune the brief and timeline with an idea of the number of meetings and stakeholder consultancy events if applicable, to be able to provide a quotation. We would envisage incorporating an architectural characteristic assessment and provide illustrations and we would liaise with you to see what maps are available for inclusion or if any further surveys would need to be commissioned or licenses obtained.

Earlier this week the conservation officer at Enfield mentioned that they are also in the early stages of scoping some heritage regeneration schemes to avail of the forthcoming grant aid from HE. We collaborated with them and their project manager on some streetscape regeneration projects in 2003-5 which were targeted at shop-fronts and façade improvements. If it would be helpful I could put you in touch with her as she may be able to share experience to help you in the planning process.

I am a member of Tenterden Town Council. Tenterden has two Conservation Areas, the main one covering the High Street and its immediate area.

As a council, we want to find ways of improving our High Street, to try to ensure its continuing relevance and activity. We envisage that part of these improvements will be improvements to the hard landscaping that is part of the public realm.

We have been advised by Ashford Brough Council, our "parent" council, that the way to do this is through a Conservation Area Management Plan (CAMP) and, while the borough council would support the preparation of a CAMP, they have no real resources available to this end, and would be happy for the town council to initiate this.

I understand that you specialise in this sort of work, and I am therefore approaching you to find out (a) whether you are interested in this project, (b) how you would envisage it being carried out and (c) the likely costs and timescale for preparing a CAMP.

I imagine that the starting point would be a Conservation Appraisal. One must have been prepared for the Conservation Areas to have been designated in the first place, but I have (so far) been unable to find it.

The borough council is due to be reviewing all the Conservation Areas in the borough; we are hoping to persuade it to put the Tenterden areas early in the review process, but again resources are limited.

I look forward to hearing from you, so I can compile a proposal and background information to put to the town council (the next opportunity will be at its committee meetings on 10 June) for discussion and progress.
